TONKAWA TRIBAL ENROLLMENT

INFORMATION ON APPLYING FOR MEMBERSHIP INTO THE TONKAWA TRIBE OF OKLAHOMA

- A. **ENROLLMENT APPLICATION:** Complete fully, put N/A for Not Applicable where necessary. If applicant is 18 or older they must sign application. Custodial parents, legal guardians or legal agents of applicant may file applications for minors (under age if 18) or incompetent persons. Applications must be completed in blue or black ink ONLY.
- B. **FAMILY TREE:** Complete as thoroughly as possible going back to Tonkawa ancestor on 1938 Tonkawa Base Roll.
- C. **ORIGINAL STATE ISSUED BIRTH CERTIFICATE:** **COPIES WILL NOT BE ACCEPTED.** Birth Certificate Certified by the State Department of Public Health of Vital Records Division from the State applicant was born in. A hospital record or document is not sufficient as proof of birth.
- D. **COPY OF SOCIAL SECURITY CARD.**

DECEMBER ROLL TRANSFER APPLICANTS:

- E. **PERSONAL LETTER:** Write a letter stating why you want to be an enrolled Tonkawa Tribal Member.
- F. **CONDITIONAL RELINQUISHMENT:** Need a letter stating your conditional relinquishment form current enrolled tribe.
- G. **DEADLINE OF NOVEMBER 1st AT 4:30PM FOR ALL ROLL TRANSFERS.**
*** ORIGINALS SUBMITTED BY MAIL WILL BE RETURNED BY CERTIFIED MAIL. ***

REQUIREMENTS FOR ENROLLMENT:

- H. All persons enrolled on the 1938 official census roll of the Tonkawa Tribe.
- I. Any person, who is not enrolled in any other Indian tribe; has at least one parent enrolled in the Tonkawa Tribe, or if the parent is deceased, was an enrolled member at the time of death; and upon written application for tribal membership is approved by the Tribal Committee.
- J. Any person, who is enrolled in any other Indian Tribe, provided they have submitted a conditional relinquishment for membership in the other Indian tribe; has at least one parent enrolled in the Tonkawa Tribe, or if the parent is deceased, was an enrolled member at the time of death; and upon written application for tribal membership is approved by majority vote of the Tribal Council at the annual meeting of Tribal Council.
- K. If the Tonkawa parent is the father, an **original DNA test**, obtained at the applicant's sole expense, must be provided to determine that a specific tribal member is the natural parent of the applicant to be not less than 97% certainty. Test must come from a certified and accredited national DNA lab testing facility.

IF APPLICABLE:

- L. If Adopted: Original or certified copies of court documents or original birth certificate(s) must prove the natural Tonkawa parent through whom eligibility is determined.
- M. Children that are not with parents and are with a legal guardian: Original court documents or certified copies must be provided that shows legal guardianship.
- N. Original or certified copies of documents to show name change that is different from birth certificate such as marriage licenses or court documents.
